The deposit will be applied to the purchase price of the puppy if a suitable puppy is available from the litter listed above. If no puppy meeting the requirements of this reservation (requested sex, color, quality) is available from this litter, the deposit shall be refunded or can be applied to reserve a puppy from a future litter. Seller may choose, to refund the full amount of the deposit to the buyer, thereby ending any and all obligation to sell buyer a dog or puppy.

The deposit shall not be refunded for any other reason (for example buyer purchasing a puppy from another breeder's litter before this puppy is available or purchaser changing their minds about buying a puppy or specific preference on exact markings of dog).
